The following year, under our leadership, 380 CEOs called on businesses, civil society, and policymakers for a New Deal for Europe. Today, we trust our collective voice will resonate even more powerfully.

- 4 Integrate Behavioral Science to support companies in the creation of products and services that address social needs, tackle unconscious bias, and overcome other barriers.
